The Cook Arts Center serves over 1,000 children annually through after-school
art, clay, dance, theatre, music, gardening and sewing classes. Summertime
programs include an arts & learning day camp during July. In addition, the
Arts Center collaborates with other organizations to plan and implement
educational events, celebrations, and festivals. After school arts served 358
children; ArtPrize education days served 279 children; Summer/winter/spring
camps served 94 children; Local schools day programming served 211 children;
girls rock camp and performances served 40 children; teen leaders program
served 26 children.

The Cook Library Center is an independent library used by students from
elementary, middle, and high schools as well as adults who reside in the
Grandville Avenue neighborhood. College students and adults volunteer weekly
during the school year to assist children with homework, read with them,
and/or play games and mentor them. There are 14 computers with internet
access for public use. The Cook Library helped 75 students with homework
and had approximately 13,575 visits during the year.

The Cook Library Scholars Program engages entire families as it prepares
youth in the Grandville Avenue neighborhood to achieve academic success and
serve as future leaders. This program offers after-school and summertime
academic support, a mentorship program, arts education, leadership and life
skills training, and other enrichment activities. The Cook Library Scholars
served 27 people during the year.
