COLLEGE STUDENTS AND ADULTS VOLUNTEER WEEKLY DURING THE SCHOOL YEAR TO ASSIST CHILDREN WITH HOMEWORK, READ WITH THEM, OR PLAY GAMES AND MENTOR THEM. THERE ARE FOURTEEN COMPUTERS WITH INTERNET ACCESS FOR PUBLIC USE.
